# Pregled

Koristite aplikaciju kako biste kreirali QR kod (šifru za brzi odgovor) koji se prikazuje na zaslonu pisača.

Koristite aplikaciju za čitanje QR koda kako biste omogućili mobilnom uređaju da interpretira kod i učinite sljedeće:

- Otvorite web-mjesto.
- Pristupite aplikaciji Embedded Web Server na pisaču koristeći zadanu vrijednost QR koda.

**Napomena:** Provjerite jesu li mobilni uređaj i pisač na istoj mreži.

Ovaj dokument sadrži upute o načinu konfiguriranja i upotrebe aplikacije te rješavanju problema s njima.

# Konfiguriranje aplikacije

Za konfiguraciju aplikacije možda će vam trebati administratorska prava.

## Pristupanje aplikaciji Embedded Web Server

- 1 Nabavite IP adresu pisača. Učinite nešto od sljedećeg:
  - Locirajte IP adresu na vrhu početnog zaslona pisača.
  - Na početnom zaslonu pisača dodirnite **Postavke > Mreža/priključci > Pregled mreže**.
- 2 Otvorite web-preglednik, a zatim upišite IP adresu pisača.

## Upravljanje QR kodovima

- 1 U aplikaciji Embedded Web Server dođite do stranice s konfiguracijom aplikacije:  
**Aplikacije > Generator QR kodova > Konfiguriraj**
- 2 Dodajte QR kod.  
**Napomena:** Možete i uređivati ili izbrisati QR kod.
- 3 Ako je potrebno, odaberite zadanu vrijednost QR koda. Ta vrijednost koristi se kada je polje "Tekst za šifriranje" prazno.
  - **IP adresa** – generirani QR kod sadrži IP adresu pisača.
  - **Naziv glavnog uređaja** – generirani QR kod sadrži naziv glavnog uređaja pisača.
- 4 U polju "Tekst za šifriranje" unesite vrijednost QR koda.  
**Napomena:** Kako biste pristupili web-mjestu koristeći QR kod, unesite URL web-mjesta.
- 5 Pritisnite **Primijeni**.

## Uvoz ili izvoz konfiguracijske datoteke

**Napomena:** Uvozom konfiguracijskih datoteka zamijenit će se postojeće konfiguracije aplikacije.

- 1 U aplikaciji Embedded Web Server dođite do stranice s konfiguracijom aplikacije:  
**Aplikacije > Generator QR kodova > Konfiguriraj**
- 2 Pritisnite **Uvoz** ili **Izvoz**.

- 2 Odaberite **Ugrađena rješenja** i učinite sljedeće:
  - a Očistite datoteku zapisnika.
  - b Za razinu bilježenja odaberite **Da**.
  - c Generirajte datoteku zapisnika.
- 3 Analizirajte zapisnik, a zatim riješite problem.
