Pregled

Aplikaciju koristite da biste kreirali QR (Quick Response – Brzi odgovor) kôd koji se prikazuje na ekranu štampača.

Pomoću aplikacije za čitanje QR kodova na mobilnom uređaju pročitajte kôd i obavite neku od sledećih radnji:

- Otvorite Web lokaciju.
- Pristupite Embedded Web Server-u štampača pomoću podrazumevane vrednosti QR koda.

Napomena: Proverite da li su mobilni uređaj i štampač na istoj mreži.

Konfiguriranje aplikacije

Za konfiguriranje aplikacije potrebna su vam administratorska prava.

Pristupanje Embedded Web Server-u

- 1 Saznajte IP adresu štampača. Obavite jednu od sledećih stvari:
 - IP adresu pronađite u vrhu početnog ekrana štampača.
 - Na početnom ekranu štampača dodirnite **Postavke > Mreža/portovi > Pregled mreže**.
- 2 Otvorite veb pregledač, a zatim unesite IP adresu štampača.

Upravljanje QR kodovima

- 1 Sa Embedded Web Server-a otvorite konfiguracionu stranicu za aplikaciju:
Aplikacije > Generator QR kodova > Konfiguriši
- 2 Dodajte QR kôd.
Napomena: Takođe možete da uredite ili da izbrišete QR kôd.
- 3 Ako je potrebno, izaberite podrazumevanu vrednost QR koda. Ova vrednost se koristi kada je polje „Tekst za šifrovanje“ prazno.
 - **IP adresa** – Generisani QR kôd sadrži IP adresu štampača.
 - **Ime hosta** – Generisani QR kôd sadrži ime hosta štampača.
- 4 U polje „Tekst za šifrovanje“ unesite vrednost QR koda.
Napomena: Da biste pristupili Web lokaciji pomoću QR koda, unesite URL adresu Web lokacije.
- 5 Kliknite na **Primeni**.
